Subject: Select List for the posts of Assistant Professor (Geology) in Higher Education Department.

Notification No. 58 – PSC (DR-S) of 2019
Dated: 27.08.2019

Whereas, the Higher Education Department referred 10 posts [OM:05, RBA:01, SC:01, ST:02 & ALC:01] of Assistant Professor (Geology) to the Public Service Commission for being filled up from amongst the suitable candidates; and,

Whereas, the Commission notified these posts vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017; and,

Whereas, in response to the above notification, 134 applications were received. Out of these, 30 eligible candidates were shortlisted and called for interview; and,

Whereas, the interview of the shortlisted candidates was conducted on 13.05.2019 and 14.05.2019 with the assistance of experts from outside the state; and,

Whereas, 12 more candidates were interviewed on the basis of Court directions in various writ petitions, the details of which are given below:-

WP (C) NO. 1642/2019 CM NO.3018/2019 TITLED DR SUMAIRA ZAZ & ORS V/S STATE OF JK & ORS

“Meanwhile, the respondent Commission shall allow the petitioners to compete in the process of selection and interview them alongwith the notified candidates on the appointed schedule, date and time. It is further directed that the selection process shall proceed as scheduled, but shall not be finalized until further orders from the Court.”

WP (C) NO. 1680/2019 CM NO.3508/2019 TITLED AVINASH BHAGAT V/S STATE OF JK & ORS

“Meanwhile, subject to objections, respondents are directed to allow him to participate in the viva/interview for the post of Assistant Professor in Geology in the Higher Education Department in pursuance to the advertisement Notice No. 10-PSC (DR-P) of 2017 dated: 27.10.2017, however, his result shall not be declared till further orders from this Court.”

WP (C) NO. 1676/2019 CM NO.3107/2019 TITLED RASIKH BARKAT V/S STATE OF JK & ORS

WP (C) NO. 1661/2019 TITLED BILAL AHMAD BHAT V/S STATE OF JK & ORS

“Meanwhile the Commission shall allow the petitioner to compete in the process of selection and interview him along with the notified candidates on the appointed schedule, date and time. The selection process shall proceed as scheduled but it shall not be finalized until further orders.”

WP (C) NO. 1595/2019 TITLED JAVAID AHMAD GANIE & ORS V/S STATE OF JK & ORS

“In the meanwhile, the Commission shall allow the petitioners to compete in the process of selection and interview them along with the notified candidates on the appointed schedule, date and time. The selection process shall proceed as scheduled but it shall not be finalized until further orders.”

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
2. In pursuance of Rule 51 of J&K PSC (Business & Procedure) Rule, 1980 and as reiterated by the Commission in the 20th extra ordinary meeting held on 20.06.2019, candidates having NET are entitled for points only from the highest qualification amongst M.Phil/Ph.D and where Ph.D itself is consumed towards eligibility the candidates are not entitled for any points.

3. The select list is provisional. Any objection may be submitted to the Commission within five days for examination and disposal. No claim will be entertained after five days from the date of issuance of Notification.
