Whereas, the J&K Public Service Commission, vide Notification **No.10-PSC (DR-P) of 2017 dated 27.10.2017** invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the **29 posts (OM: 16, RBA: 06, SC: 02 and ST: 03)** of Assistant Professor, **Music** in Higher Education Department and in response to the above said Notification, the Commission received **42** applications in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 13.02.2019; and

Whereas, the deficient documents were received from the candidates in response to notice dated 13.02.2019 and the said documents were again verified/scrutinized by the Screening Committee for short listing of the candidates for interview; and

Whereas some representations were received from the candidates regarding rejection of their candidatures which were disposed off on merits ; and

Whereas, the number of eligible candidates was lesser in number than the ratio required for shortlisting of the candidates for interview under OM category and as such all the eligible candidates are called for interview ; and

Whereas, 07 candidates under SC category secured marks above the candidate in the bottom of the merit under OM category as such all the candidates under SC category are called for interview in their respective category and no eligible candidate is available against the RBA and ST category ; and

6. **The candidates shall bring along with them the respective Musical instruments at the time of interview , the accompanist however shall be arranged by JKPSK itself.**
