Whereas, vide Notification No. PSC/Exam/2019/14, dated 21.02.2019 application forms for appearing in Secretariat Assistant Course/Foundation Course Departmental Examination were invited from eligible candidates; and

Whereas, in response, 389 candidates applied for Secretariat Assistant Course and 338 candidates applied for Foundation Course, Departmental Examinations (total 727) to the said notification; and

Whereas, on scrutiny of the application forms, it has been found that out of 727 candidates, 39 (SAC-17, FC-22) have not submitted hard copies of their application forms up to the last date i.e. **18.03.2019** and further 29 (SAC-20, FC-09) candidates have not submitted Training Certificate issued by the IMPA/GAD; and

Whereas, vide notice dated 30.05.2019, these 68 candidates (SAC-37, FC-31) were advised to submit their requisite deficient documents and in response, only 17 candidates (SAC-08, FC-09) submitted their requisite deficient documents and rest 51 (SAC-29, FC-22) candidates failed to submit their requisite documents; and

Whereas, 18 (SAC) candidates out of these 51, had submitted the hard copies of their application forms only but did not submit their training completion certificate issued by the IMPA; and

Whereas, rest 33 (SAC-11, FC-22) candidates failed to submit the requisite documents.

Now in view of above, the candidature of these 33 (SAC-11, FC-22) candidates is hereby rejected due to the reasons shown against each.

Whereas. General Administration Department vide letter No. GAD(Estt)M-08/2017 dated 31.01.2020, has intimated that undergoing Secretariat Assistant Training Course conducted by the department is a pre-requisite for appearing in the SAC and these 18 candidates have not been granted any exemption for appearing in the said Examination.
