**Subject: Revised Select List for the posts of Assistant Professor (Physics) in Higher Education Department.**

## **Notification No. 18 – PSC (DR-S) of 2021**

**Dated: 24.03.2021**

Whereas, Higher Education Department vide letter No. HE-Coll/COORD/APPTT/AP/2017 dated 18.10.2017 referred 12 posts [OM:05, RBA:02, SC:01, ST:02, ALC:01 & SLC:01] of Assistant Professor in the discipline of Physics for selection suitable candidates; and

Whereas, J&K Public Service Commission vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017 advertised the said posts for selection of suitable candidates; and

Whereas, in response to the above notification 195 applications were received, out of these 33 eligible candidates were shortlisted and called for interview; and

Whereas, the interview of the shortlisted candidates was conducted on 26.03.2019 and 27.03.2019 with the assistance of experts from outside the state (now UT); and

Whereas, aggrieved by the non-inclusion of the names in the Selection list the Commission received various representations from the candidates projecting grievances on the grounds that they have submitted their Ph.D thesis publications during the time of interview and the same were entertained and awarded marks accordingly. As per Rule 51 of J&K Public Service Commission (Business & Procedure) Rules, 1980 only such publications are to be entertained which were not the part of Ph.D thesis; and

Whereas, this matter was required to be looked into only by the Experts, the Commission decided to invite the concerned Subject Experts for reassessment of the award points in respect of special attributes and to verify the Publications and Presentations; and

Whereas, due to the enactment of J&K Reorganization Act, 2019 and after the Commission was deemed to have held office till 31.10.2019 together with outbreak of COVID-19 pandemic the reassessment of award points in respect of Special attributes and the verification of Publications and Presentations could not finalized till May 2020. The matter was reviewed after the Commission was reconstituted, wherein, it was decided to call the same subject experts (who have come for the Interview) for reassessment of the points with regard to Special Attributes. However, due to the COVID-19 pandemic the said Experts expressed their unwillingness to come again for the said assignment. The Commission then called two eminent Experts for reassessment of the Special Attributes. The subject matter experts examined and compared the Publications/Presentations with the Ph.D/M.Phil thesis; and

Whereas, 01 post under ALC category left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and all other relevant parameters after making necessary corrections with regard to the special attributes, the merit of the candidates who have appeared in the interview has been framed and is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the above, the **revised select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

**Note:-**

1. The Commission reserves the right to have certificates/documents of the candidate verified, if at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. In pursuance of Rule 51 of J&K PSC (Business & Procedure) Rule, 1980 amended from time to time and as reiterated by the Commission in the 20th extra ordinary meeting held on 20.06.2019, candidates having NET are entitled for points only from the highest qualification amongst M.Phil/Ph.D and where Ph.D itself is consumed towards eligibility the candidates are not entitled for any points.
3. The select list is provisional, objection if any may be submitted to the Commission within five days for examination and disposal. No claim whatsoever shall be entertained after five days from the date of issuance of the Notification.
