Subject:- Amendment to Rules 12A(c) and Rule 17 of the Jammu and Kashmir Public Service Commission (Conduct of Examinations) Rules, 2005.

It is hereby notified for the information of the general public that -

(a) the existing Rule 12A(c) of the Jammu and Kashmir Public Service Commission (Conduct of Examination) Rules, 2005 shall be substituted as under:-

"12 A (c):. In case the team of the experts confirm the incorrectness of the questions/answers/options, the concerned questions shall be deleted from the paper and the marks allocated therefore **shall be individually added to the marks secured by the individual candidates** to ensure that the marks allocated for the question paper as a whole remain unchanged."; and

(b) Rule 17 of the Jammu and Kashmir Public Service Commission (Conduct of Examination) Rules, 2005 shall be substituted as under:-

"17. Admission of candidates in the Examination Hall:- Entry into the Examination hall be closed 30 minutes before the scheduled commencement of the Examination. No candidate shall be allowed entry into the examination venue after closure of entry. No functionary has any discretion in this regard.

No candidate should be allowed to leave the examination hall until expiry of the full time for the paper. However, if a candidate falls seriously ill and is unable to write the examination any longer, the

question paper and the OMR/Answer Sheet may be taken from him and then he may be sent to a nearby Hospital/Dispensary, duly accompanied by an invigilator, for treatment”.

Note: This shall come into force with immediate effect.
