Whereas, Higher Education Department vide letter HE-Coll/COORD/APPTT/AP/2017 dated 18.10.2017 referred 25 posts [OM:15, RBA:05, SC:02, ST:03] of Assistant Professor in the discipline of Music for selection of suitable candidates; and

Whereas, J&K Public Service Commission vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017 advertised 25 posts (Fresh) in the discipline of Music and 02 posts [OM:01, RBA:01] of Assistant Professor in the discipline of Music Instrument (Ist Spl. Drive) referred vide letter No.Edu-Coll/774/2013 dated 22.03.2013 read with letter No.HE-Coll/COORD/Apptt./AP/2014 dated 19.05.2014 for selection of suitable candidates; and

Whereas, Commission received 40 applications (Fresh: 37, Ist Spl Drive:03), which were scrutinized and 23 (Fresh:22, Ist Spl Drive:01) eligible candidates were called for interview; and

Whereas, the interview of the shortlisted candidates was conducted on 28.01.2021 & 29.01.2021 with the assistance of experts; and

Whereas, 01 post under Open Merit, 05 posts under RBA category and 03 posts under ST category have been left vacant due to non-availability of candidates. Further, one post under RBA category advertised under Ist Special drive has also been left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit list of the candidates who have appeared in the interview is enclosed as **Annexure-**"A" to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification. Further, the result of 04 candidates as per details given below has been kept withheld for want of requisite documents indicated against each:-
