Whereas, the prescribed qualification for the post of Lecturer, in Bio-Chemistry is postgraduate degree in Bio-Chemistry i.e. MD, Ph. D, D. Sc with two year's teaching experience in medical institution recognized by the Medical Council of India. The teaching experience, if any gained before or during the post graduation studentship shall not be considered while determining the eligibility for the post of Lecturer; and

Whereas, Mr. Asif Khurshid has submitted two experience certificate one from Government Medical College, Baramulla in which the Principal Government Medical College Baramulla certified that Dr. Asif Khurshed worked as Demonstrator in the Department of Bio-chemistry w.e.f. 02-01-2019 to 05-04-2009; and

Whereas, another experience certificate has been issued by the Administrative Officer (Academic) SKIMS in January 9th 2019 in which it has been certified that Dr. Asif Khurshid (SR/3015) is working as Senior Resident in the department of Immunology and Molecular Medicine SKIMS Soura on tenure basis since 15-12-2016 and is continuing till date; and

Whereas, the teaching experience gained as Senior Registrar in the department of Immunology and Molecular Medicine SKIMS Soura is not in the relevant discipline (Bio-Chemistry) as prescribed in the rules as such the same cannot be considered for determining the eligibility for the post of Lecturer Bio-Chemistry; and

Whereas, the candidate has only 3 months and 3 days relevant experience i.e. in GMC Baramulla against the required experience of two years as prescribed in the rules, therefore, is not eligible for the post of Lecturer, Bio-Chemistry.
