**Subject: Conduct of the J&K Combined Competitive (Preliminary) Examination, 2018 - Deficiency reg;**

**Notice**  
**Dated:14.09.2018**

Whereas, vide Notification No.PSC/Exm/2018/38 dated 25.05.2018 read with Notification No. PSC/Exam/2018/46 dated:18.06.2018 online applications were invited from permanent residents of the State of Jammu & Kashmir, for J&K Combined Competitive (Preliminary) Examination-2018, in accordance with SRO-103 of 2018 dated 23.02.2018 & J&K Public Service Commission (Conduct of Examination) Rules, 2005; and

Whereas, in response 35,977 online application forms were received; and

Whereas, upon scrutiny of the online application forms it was observed that some applicants had not deposited the requisite fee notwithstanding submission of the online application form by them. Besides, some other candidates had filled in the application form claiming age relaxation on account of being in-service candidates whereas in actual they were found to be not holding a Civil post, in substantive capacity, in the Government of Jammu and Kashmir as would entitle them to grant of relaxation in the upper age limit; and

Whereas vide notice dated:17.08.2018 issued under endorsement No.PSC/Exam/KAS(Pre)/2018 dated:17.08.2018, among others, the candidature of Mr. Narinder S/o Shri Bodh Raj bearing Form No. 18023800007177 was rejected on account of being overaged, as on 01.01.2018. He however being entitled to prefer an appeal, before the J&K Public Service Commission at Solina Srinagar, against the rejection of his candidature was informed to prefer an appeal if he so desired, subject to substantiating his claim with the supporting documents, within seven days from the date of issuance of the notice, intimating further that after expiry of the said date no appeal, whatsoever, would be entertained; and

Whereas, 1123 candidates, among whom Mr. Aditya Gupta S/o Mr. Kulbir Gupta bearing Form No.: 18023800004778 also figured, were advised to submit the proof of having deposited the requisite fee well within the cutoff date i.e. 31.07.2018, within a period of seven days from the date of publication of the notice ibid at Commission offices at Solina Srinagar/Resham Ghar Colony, Bakshi Nagar, Jammu intimating that in the event of their failure to do so, their candidature shall be rejected without any further notice; and

Whereas, in response to the said notice, 21 representations along with the documentary evidence were received within the stipulated time, praying therein for release of admit cards in their favour; and

Whereas, upon consideration of these representations and pending further verification in consultation with the concerned banks, it was decided to release the admit cards in favour of the following candidates enabling them to appear in the J&K Combined Competitive (Preliminary) Examination-2018, scheduled on 02.09.2018(now on 16.09.2018) intimating further that the candidature shall be purely provisional and on the risk and responsibility of the candidates:

Whereas, a notice dated:30.08.2018 issued under endorsement no.PSC/Exam/KAS(Pre)/2018 dated:30.08.2018, detailing all the facts relevant to the case was accordingly issued; and

Whereas, Mr.Narinder S/o Shri Bodh Raj bearing Form No. 18023800007177 whose candidature was rejected in terms of notice dated:17.08.2018 preferred an appeal before the Hon'ble Court in SWP No.1762/2018 titled Narinder Kumar Vs State of J&K & Anr in which the following order dated:31.08.2018 has been passed by the Hon'ble Court:

*Meanwhile, subject to objections from the other side and till next date before the Bench, the respondent No.2 shall accept the application form of the petitioner and allow him to sit in the preliminary examination provided he is otherwise eligible on his own risk and responsibility. The result of the petitioner, however, shall not be declared without further orders from this Court.*

In another writ petition OWP No.1741/2018 titled Aditya Gupta Vs State & Ors filed by Mr. Aditya Gupta S/o Mr. Kulbir Gupta bearing Form No.: 18023800004778 whose candidature was rejected in terms of notice dated:30.08.2018, the Hon'ble Court passed the following interim order on 11.09.2018:

*it is directed that the petitioner shall be allowed to appear in the examination on provisional basis. It is made clear that appearance of the petitioner in the aforesaid examination shall not create any equity or right in his favour and his result shall not be declared without leave of this Court.”*

Now, therefore, the following two candidates are hereby allowed to appear in the J&K Combined Competitive (Preliminary) Examination-2018, scheduled on 16.09.2018, on provisional basis, in pursuance of the orders dated: 31.08.2018 & 11.09.2018 passed by the Hon'ble Court in writ petitions SWP No.1762/2018 titled Narinder Kumar Vs State of J&K & Anr and OWP No.1741/2018 titled Aditya Gupta Vs State & Ors respectively:
