Whereas, the Jammu and Public Service Commission vide Notification PSC/Exam/2013/111 dated: 24.12.2013 invited applications from the permanent residents of the State for appearing in the Jammu and Kashmir Civil Service (Judicial) Competitive Examination, 2013 the conditions for eligibility were laid down; and

whereas, the Main Examination was held w.e.f. 10.11.2016 to 23.11.2016; and

whereas, the result of the said examination was declared on 21.06.2017 vide Notification No. PSC/Exam-17/36-A dated: 21.06.2017; and

whereas, on the basis of criteria fixed by the Commission, a total number of 71 candidates have been declared by the Commission to have qualified for appearing in the viva voce; and
