Sub:-Recommendation of Selection for the Post of Lecturer, (10+2)
Urdu in School Education Department.

Notification No:-20 -PSC (DR-S) of 2017

Whereas, the result of selection for the post of Lecturer, (10+2) Urdu in School Education Department was declared vide Notification No:-15-PSC (DR-S), Dated:-31-03-2017, and

Whereas, after issuance of the above Notification, a representation was received by the Commission from one Mr. Manzoor Hussain Kumar S/O Abdul Satar Kumar figuring at S.No:-115 of the General merit list claiming that he has not been selected in the SLC Category in spite of the fact that the merit of the candidate namely Khursheed Ahmad Ganie S/O Abdul Salam Ganie who has been selected in the said category is equal to his merit of 79.25 points. He has also claimed that he has not been considered in the waiting list of the Open Merit Category whereas the candidates with lower merit than him have been reflected in the said list.

Whereas, the representation was thoroughly examined and the Commission arrived at the following conclusions:-

“So far as his claim of selection in the SLC Category is concerned, he could not be selected in the said category as the candidate namely Khursheed Ahmad Ganie with merit position of 79.25 points has qualified NET in addition to MA and M. Phil Degrees. Keeping in view the preferential qualification, Mr. Khursheed Ahmad Ganie S/O Abdul Salam Ganie has been selected in the SLC Category. His claim of consideration in the waiting list of the Open Merit Category was found based on facts and as such he should have figured at S.No:-6 of the waiting list of the said category below Arshad Ahmad Kuchay with merit position 79.50. Due to his inclusion in the waiting list of the Open Merit Category, the candidate namely Muzaffer Manzoor S/o Manzoor Ahmad Bhat figuring at S. No:-7 of the waiting list

with merit position 78.88 shall and always be deemed to have been excluded from the waiting list”.

Now, therefore, in partial modification of Notification No:- 15-PSC (DR-S), dated:-31-03-2017, the following candidates are hereby included/excluded in the result:-

1. Mr. Manzoor Hussain Kumar S/O Abdul Satar Kumar R/o Waghama Bijbehara with merit position as 79.25 is included in the waiting list at S.No:-6 of the Open Merit Category.
2. Mr. Muzafar Manzoor S/o Manzoor Ahmad Bhat R/o Khan Bazar Cheeni Chowk Anantnag shall and shall always be deemed to have been excluded from the waiting list.
