## Order No. 178-PSC of 2018 Dated: 1/-10-2018

Whereas, the Higher Education Department, Vide Communication No. Edu/Coll/Apptt./A.P/2014, dated 19.05.2014, among other posts had referred 50 posts (OM=27, RBA=12, SC=04, ST=05, & ALC=02) of Assistant Professors in the discipline of Economics to the J&K, Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

Whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014, dated 29.05.2014, invited applications on prescribed format from the permanent residents of Jammu and Kashmir possessing the prescribed qualification. In the said notification, it was, inter-alia, mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC (DR-P) of 2013, dated 23.05.2013, for the above mentioned post (s) need not to apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014; and

Whereas, in pursuance of the Commission's decision taken in its extra ordinary meeting held on 06.01.2016, all such candidates, who had qualified their SET/NET by virtue of revised notifications, were informed through the medium of the notice dated 07.01.2016 to submit their applications alongwith the documentary proof of having qualified SET/NET in 2013 together with other documents to participate in interview process in their respective subjects as and when the interview schedule in their cases is notified provided they were otherwise eligible on the cutoff date i.e 02.07.2014; and

Whereas, in pursuance of the said Notice dated 07.01.2016, among other candidates also submitted their representations candidates, the following two alongwith other documents for the posts of Assistant Professor in the disciplines of Economics:-

Now, therefore, on the basis of performance of the aforesaid candidates, in the interview coupled with the weightage in respect of academic merit, experience and other related parameters for the post of Assistant Professor, Economics, position of below mentioned candidates is as under:-

The above candidates do not fall in the selection zone as the last selected candidate under Open Merit Category has secured 60.43 points whereas Sh. Mohd Imran Lone who secured 47.95 points and Sh. Roof Ahmad Wani who secured 58.96 points cannot be considered for selection for the post of Assistant Professor in Economics.
