Note:


- i. The candidature of candidates shown in **Annexure –A** is purely provisional;
- ii. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the Oral Test/Interview subject to the condition that they are within the prescribed age limit on the cut off date.
- iii. The candidates who qualified the Written Test are advised to submit copy of their online application form along with fee receipt at J&K PSC office, Solina Srinagar/Resham Ghar Colony Bakshi Nagar Jammu or send by post to the address of “**Controller of Examinations, J&K Public Service Commission, Resham Ghar Colony, Bakshi Nagar Jammu**” by registered post and only such identified documents shall be received as have been posted by or before 18.01.2018 and delivered in the Commission by 20.01.2018.
- iv. Candidates possessing Degrees through distance mode shall have to produce a proof of having degree within the purview of Government

Order No. 252-HE of 2012 dated: 30.05.2012 from Competent Authority of the concerned University.

- v. The candidates shall produce their original certificates/testimonials on the date of oral test/Interview.
- vi. Oral Test/Interview of the eligible candidates shall be held w.e.f **29.01.2018**. However, the detailed schedule for Oral Test/interview will be notified separately.

This is subject to the outcome of writ petitions, pending disposal before the Hon'ble High Court of J&K.
