In pursuance of Rule 32 of J&K Public Service Commission (Conduct of Examinations) Rules, 2005 read with Rule 40 of J&K Public Service Commission (Business & Procedure) Rules, 1980, the candidates as per Annexure-A to this notification are hereby declared to have qualified for the Oral Test for the posts of Lecturer 10+2 Botany in School Education Department on the basis of their performance in the Written Test which was held on 12.06.2016.

Note:

- i. The candidature of candidates shown in Annexure -A is purely provisional;
- ii. Only eligible candidates possessing requisite qualification prescribed under rules shall be allowed to appear in the Oral Test subject to the condition that they are within the prescribed age limit on the cut off date.
- iii. The shortlisted candidates are advised to submit copy of their online application form along with fee receipt within 07 days at J&K PSC office, Solina Srinagar/Resham Ghar Colony Bakshi Nagar Jammu.
- iv. Candidates possessing Degrees through distance mode shall have to produce a proof of having degree within the purview of Government Order No. 252-HE of 2012 dated: 30.05.2012 from Competent Authority of the concerned University.
- v. The candidates shall produce their original certificates/testimonials on the date of oral test.

- a. Oral Test/Interview of the eligible candidates shall be held w.e.f **17.07.2017 (tentatively)**. However, the final and detailed Oral Test/interview schedule will be notified separately.

This is subject to the outcome of any writ petition pending disposal before any competent Court of Law.
