Whereas, the Health & Medical Education Department referred 02 posts [RBA:01 & SC:01] of Deputy Medical Superintendent vide letter No. HME/HRM/02/2016 dated 09.03.2016 for GMC, Srinagar & 02 posts [OM:02] of Deputy Medical Superintendent vide letter No. ME/Gaz-215/2010 dated 14.12.2016 for GMC, Jammu for recommendation of selection of suitable candidates; and

Whereas, the J&K Public Service Commission advertised these posts vide Notification No. 12-PSC (DR-P) of 2016 dated 22.04.2016 and No.19-PSC (DR-P) of 2016 dated 19.12.2016; and

Whereas, 08 applications and 13 applications were received pursuant to Notification No. 12-PSC (DR-P) OF 2016 dated 22.04.2016 and 19-PSC (DR-P) OF 2016 dated 19.12.2016 respectively. Out of these, 02 candidates under first notification and 02 applicants under second notification were found eligible and called for interview; and

Whereas, the interviews of the candidates were conducted on 17.05.2018 with the assistance of experts from outside the State; and

Whereas, one post under SC category against Notification No.12-PSC (DR-P) of 2016, GMC, Srinagar left vacant due to non-availability of candidate. Further, 01 post under Open Merit against Notification No.19-PSC(DR-P) of 2016, GMC, Jammu left vacant as the candidate could not fulfil the bench mark of 55 points.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the list of the candidates who have appeared in the interview is enclosed as Annexure-“A” to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
