**Dated: 11.09.2018**

Whereas, School Education Department referred 04 posts [OM-02, RBA-01 & SC-01] of Lecturer vide letter No. Edu/V/4/2008 dated:16.03.2016 in the discipline of Geology for recommendation of selection of suitable candidates; and

whereas, the J&K Public Service Commission advertised these posts vide Notification No. 09-PSC (DR-P) of 2016 Dated 19.03.2016; and

whereas, in response to the above notification, 327 applications were received; and

whereas, the written test of the candidates for selection was conducted on 29.04.2018 in which 194 candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2018/46 dated: 11.06.2018 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and 31 candidates were declared to have qualified the written test and called for interview; and

whereas, the interview of the shortlisted candidates was conducted on 16.08.2018 and 18.08.2018 with the assistance of experts; and

whereas, one candidate namely Masrat Ahad bearing B.D. No.28 was rejected by the Interview Board as he did not possess the requisite qualification at the time of application and interview as well; and

whereas, the Hon'ble High Court in SWP NO.1392/2018, MP No.1/2018 titled Javid Ahmad Ganie and Others V/S State of J&K another passed orders as below:-

*“IA is disposed of with a direction to the respondents-Public Service Commission to allow the petitioners to sit in oral test/viva-voce on the basis of their performance in the written test held on 28.04.2018 for the post of Lecturer in the discipline of Geology pursuant to advertisement notification No. 09-PSC (DR-P) of 2016 dated:19.03.2016 at their own risk & responsibility. However the result shall not be declared till further orders from the Court.”*

On the basis of performance in the written test, 04 candidates were allowed to appear before the Interview Board in compliance to above court direction.

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Further, the marks obtained by the candidates who appeared in the written examination on 28.04.2018 are given in **Annexure-C** to this notification for information of the candidates.

The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
