Whereas, School Education Department referred 03 posts [OM-01, RBA-01 & SC-01] of Lecturer vide letter No. Edu/V/4/2008 dated:16.03.2016 in the discipline of Kashmiri for recommendation of selection of suitable candidates; and

whereas, the J&K Public Service Commission advertised these post vide Notification No. 09-PSC (DR-P) of 2016 Dated 19.03.2016; and

whereas, in response to the above notification, **359** applications were received; and

whereas, the written test of the candidates for selection was conducted on 28.04.2018 in which **161** candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2018/57 dated: 27.07.2018 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and 11 candidates were declared to have qualified the written test and called for interview; and

whereas, the interview of the shortlisted candidates was conducted on 16.08.2018 with the assistance of experts; and

whereas, One post under SC category left unfilled due to non-availability of the candidate.

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Further, the marks obtained by the candidates who appeared in the written examination on 28.04.2018 are given in **Annexure-C** to this notification for information of the candidates.

The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
