Whereas, the School Education Department referred 01 post under OM Category of Lecturer in the discipline of Statistics to the Public Service Commission for being filled up from amongst the suitable candidates; and

whereas, the Commission notified the post vide Notification No. 09-PSC (DR-P) of 2016 dated 19.03.2016; and

whereas, in response to the above notification, 178 applications were received; and

whereas, the written test of the candidates for selection was conducted on 12.06.2016 and 155 candidates appeared in the written test. The result of the written test was declared vide Notification No. PSC/Exam/2017/16 dated: 23.03.2017 in pursuance of Rule 32(a) of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 and Rule 40 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time; and

whereas, the interview of the 05 candidates on the basis of written test was conducted today on 03.04.2017.

Now, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the Merit of the candidates who have appeared in the interview is enclosed as Annexure-“A” to this Notification.

Consequent upon the above, **Ms Isha Gupta D/o Shakti Bushan Gupta R/o House No.25 Sec.-2 near post office Channi Himmat Jammu**, is recommended for selection for the post of Lecturer (10+2) in the discipline of Statistics in School Education Department.
