Whereas, the Health and Medical Education Department vide communication No. ME/GAZ/183/2015 dated 08.01.2016, referred 01 post [OM:01] of Lecturer Bio-Chemistry (clinical) to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates; and

whereas, the J&K Public Service Commission, vide Notification No. 11-PSC (DR-P) of 2016 dated 22-04-2016, notified this 01 post of Lecturer Bio-Chemistry (clinical) and invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification; and
