Whereas, the Health and Medical Education Department vide communication No. HME/HRM/80/2013 dated 24-03-2014, among others, referred 21 posts (OM=11, RBA = 04, SC= 02, ST= 02, ALC =01 and SLC= 01) of Consultant in the discipline of Orthopedics to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates;
