
Whereas vide this Commission's Notification No:-60-PSC (DR-S) of 201, dated:-26-09-2012, you were selected as the Lecturer 10+2 Environmental Science in School Education Department, and

Whereas, an aspirant for the said post namely, Mohammad Rafiq, S/o Mohammad Latief, R/o Firdous Abad, Lane No. 6 Batmaloo Srinagar, approached this Commission and the Hon'ble Governor, J&K State with a complaint that you have produced a fake experience certificate and managed your selection as Lecturer 10+2 Environmental Science in School Education Department, and

Whereas, an inquiry was conducted in the matter on the basis of record obtained from the Awadhesh Partap Singh University, Rewa (M.P.) and Principal Public School English Medium, Bijbehara and it has been observed that the experience of 7 Months and 25 days as accounted for in the selection coincides with the period of your pursuing M. Phil Degree as a regular candidate, and

Whereas, after deducting the experience of 7 Months and 25 days (0.5 points), you are excluded from the selection zone.

Now, therefore, on the basis of the above mentioned facts, you are asked to show cause within a period of 10 days from the date of publication of this notice as to why your selection on the production of fabricated and fake experience certificate should not be cancelled. Your reply in support of your defence, if any of being eligible, should reach to the Office of the Public Service Commission at Solina, Srinagar within 15 days, failing which it shall be presumed that you have nothing to say in your defence and further action in the matter shall be taken under rules without any further notice.
