Whereas, the Health & Medical Education Department, again, vide letter No. Me-GZtd/246/2022 e-Office dated 05.12.2022 and No. ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023 referred three (03) posts under open merit category one each in GMC Baramulla, Kathua and Rajouri of **Assistant Professor, Dermatology,** to the J&K Public Service Commission, for selection; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023, advertised the said posts for selection; *and*,

Whereas, written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/84 dated: 14.11.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date; *and*,

Whereas, five (05) candidates were shortlisted for GMC Baramulla, 03 for GMC Doda, 05 for Handwara, 05 for GMC, Kathua, 04 for GMC Rajouri and 05 for GMC



Udhampur. Since, some candidates have applied against multiple posts, in all only 12 candidates had to be called for interview; and,

Whereas, the viva-voce of candidates was conducted on 17.11.2023, with the assistance of Expert from outside of UT.
