**Subject: -** Consideration order in compliance to Hon'ble Central Administrative Tribunal order dated 12.10.2021 passed in OA No. 1564/2021 titled Manzoor Ahmad Lone V/s UT of J&K & Ors.

**Order No. 250 -PSC of 2023.**


1. Whereas, the Health and Family Welfare Department vide Letter No HME/HRM/64/2019 dated 19.09.2019 referred 20 posts of Consultant in discipline of Surgery for selection; and,
2. Whereas, the J&K Public Service Commission vide advertisement Notification No 12-PSC(DR-P) of 2019, dated 01.10.2019 advertised the said posts; and,
3. Whereas, the Commission received 186 applications, which were scrutinized and 175 eligible candidates were called for the interview; and,
4. Whereas, the interview of the shortlisted candidates was conducted w.e.f 13.09.2021 to 16.09.2021 with the assistance of the experts; and,
5. Whereas, one candidate namely, Manzoor Ahmad Lone filed an OA before the Hon'ble Central Administrative Tribunal, Srinagar contending therein that although he was eligible but was not called for the interview for the post of Consultant Surgery; and,
6. Whereas, the Hon'ble Tribunal disposed of the supra OA with the following directions:

*"in view of the limited prayer made by the learned counsel for the applicant, the OA is disposed of with the directions to the*

*respondents to treat this OA as representation of the applicant and dispose of the same by passing a reasoned speaking order within a period of 15 days from the date of receipt of certified copy of this order''*

7. Whereas, in compliance, the applicants representation was considered in light of the above Court Orders. It was found that the experience certificate submitted by the applicant was not authenticated by the CMO or Director Health Services, as was done in the cases of other eligible candidates. Accordingly, his representation, along with others representations, was disposed of vide Notice dated 03.12.2021. However, the applicant was given ample opportunity, even after disposal of his representation to have his experience certificate authenticated but he failed to do so. Therefore, was not interviewed being in-eligible. Moreover, the applicant was never shortlisted for the interview. In fact another candidate with same name as the applicant, who was otherwise fully eligible, and whose name was mentioned in the interview notice, was called for interview.

Now, therefore, the claim of the applicants having been considered in light of the Orders of the Hon'ble Central Administrative Tribunal, dated 12.10.2021 passed in OA No. 1564/2021 titled *Manzoor Ahmad Lone Vs UT and Ors* has been found devoid of any merit and is hence rejected.
