Whereas, the Higher Education Department, vide letter No. HE/Coll/Coord/Apptt/A.P./2021 dated: 05.07.2021 and No. HED-GAZ/85/2022-04 dated: 13.04.2022 referred one (01) post, under OM Category of Assistant Professor (Sericulture) to the J&K Public Service Commission, for selection. The J&K Public Service Commission advertised the said post vide Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023; and

Whereas, the written test was conducted on 27.08.2023 and the result thereof was declared vide Notification No. PSC/Exam/S/2023/74 dated: 03.11.2023. The viva-voce of the candidates was conducted on 07.11.2023; and

Whereas, the provisional Select List was issued vide Notification No. 89-PSC (DR-S) of 2023 dated 08.11.2023, subject to objections, to be received within five days; and

Whereas, in response to the above Notification, two representations have been received from the following candidates:

- (ii) Ms. Mokshe Sajgotra

Whereas, the summary of the representations and the consideration is given in the table hereunder:-
