In pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examinations) Rules, 2022 as amended upto date read with Rule 31, 43 and 44 of J&K Public Service Commission (Business & Procedure) Rules, 2021, the candidates as per **Annexure-A**, **B**, **C**, **D**, **E**, **F** and **G** to this notification are hereby declared to have qualified for the Oral Test/Viva Voce for the post of **Lady Medical Officer (RTHC)** and **Lady Medical Officer (UTHC)** in Health and Medical Education Department on the basis of their performance in the Written Test which was held on 04.11.2023. - iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.
