Whereas, Health & Medical Education Department, vide letter No. MEGAZ-53/2020 DT: 28.09.2020, MEGAZ-187/2014 DT: 11.08.2021, referred one (01) post of Lecturer Nephrology (Super Specialty Hospital GMC-Srinagar) under Open Merit category, for selection of a suitable candidate; and,

Whereas, the J&K Public Service Commission, vide Notification No. 12- PSC (DR-P) OF 2021 dated: 14.12.2021, advertised the said post for selection of a suitable candidate; and,

Whereas, the Commission received 08 applications, which were scrutinized and 07 candidates were called for interview, including one petitioner who was interviewed on the basis of order from the Hon'ble Central Administrative Tribunal with further direction to keep his result in sealed cover; and,

Whereas, one candidate remained absent and did not participate in the interview.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 44 of the J&K Public Service Commission (Business & Procedure) Rules, 2021 and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the facts stated here-in-above, **Dr. Muzamil Latief S/o Latief Ahmad Banday R/o 54 Najan Beerwah, having secured 80.44 points**, is provisionally selected against the available post.
