Subject: Select list for the posts of Lecturer Conservative Dentistry & Operative Dentistry (IGGDC-Jammu/GDC-Srinagar)-**Disposal of representation thereof.**

NOTICE DATED: 16-03-2023

Whereas, two posts of Lecturer Conservative Dentistry & Operative Dentistry, one each, in Government Medical College, Srinagar and Indira Gandhi Government Dental College Jammu, under OM Category, were advertised vide Notification No. 16-PSC(DR-P) of 2022 dated 12.07.2022 and No. 13-PSC(DR-P) of 2021 dated 15.12.2021; and

Whereas, the interview of eligible candidates was conducted on 14.02.2023 and the provisional Select List was issued vide Notification No. 02-PSC(DR-S) of 2023 dated 15.02.2023, and;

Whereas, a joint representation has been received from (i) Ajmal Mir, (ii) Ankush Jasrotia, (iii) Omer Hussain and (iv) Malik Sartaj Ahmad against the select list, alleging that:-


- Selected candidates have been given weightage for experience acquired as Lecturer when only 02 years' teaching experience as Registrar/ Demonstrator/ Tutor should have been considered.*
- Experience certificate of four candidates which have been issued after the cut-of-date, have been considered for weightage.*
- Paper presentation presented in conference by the representees were rejected for producing only certificates or brouchers while as same were accepted in respect of one selected candidate.*
- Some candidates were given weightage of paper presentation on the basis of having publication in Journals.*

Whereas, the experience as Lecturer and above is superior to the one gained as Registrar/Sr. Resident/Tutor/Demonstrator and is, hence, considered for grant of weightage, and;

Whereas, no weightage has been accorded to the experience granted after the cut-off date, and;

Whereas, the evaluation and assessment of the special attributes like publication, presentation is domain of the experts and the Public Service Commission accepts their assessment.

Now, therefore, in view of the afore-quoted facts, the claim of the representees is hereby considered and rejected being devoid of any merit.
