Subject: Representation for consideration of Experience Certificate for the post of Lecturer Cardiology, SSH, Govt. Medical College, Jammu- **Disposal of representation thereof.**

Whereas, Dr. Nasir Ali, candidate for the post of Lecturer Cardiology (Super Speciality Hospital) GMC, Jammu, filed O.A No. 61/211/2023 before the Hon'ble Central Administrative Tribunal praying for grant of weightage of 02 points for the experience gained by him as Cardiologist in GMC(Super Speciality Hospital) Jammu.

Whereas, the Hon'ble Central Administrative Tribunal vide order dated 01.03.2023 has disposed of the O.A with the following directions:-

"Secretary, Jammu and Kashmir Public Service Commission, Jammu to decide the applicant's pending representation dated 24.02.2023 and pass a reasoned and speaking order in accordance with law. Before taking such a decision, the applicant shall also be afforded an opportunity of hearing. The whole exercise shall be undertaken within a period of ten days from the date of receipt of a certified copy of this order.

So long as, the applicant's representation remains pending with the Secretary, Jammu & Kashmir Public Service Commission, Jammu, the selection process for the post of Lecturer Cardiology, Government Medical College (Super Speciality Hospital), Jammu shall not be finalized."

Whereas, the representation of the candidate was considered/examined in light of the orders passed by the Hon'ble Central Administrative Tribunal and he was given an opportunity of being heard on 08.03.2023; and,

Whereas, he reiterated what he has stated in his application; and,

Whereas, 02 posts of Lecturer Cardiology, one each under OM and RBA category in Super Speciality Hospital, Government Medical College, Jammu, were advertised vide Notification No. 12-PSC (DR-P) of 2021 dated 21.12.2021; and,


Whereas, the eligible candidates including Dr. Nasir Ali, were called for interview vide Notice dated 06.02.2023, which was conducted on 22.02.2023; and

Whereas, in the interview Notice, it was expressly mentioned that the candidature of all the applicants is purely provisional. The documents of the candidates will be again verified at the time of interview. In case any discrepancy, with regard to age and other eligibility conditions is noticed at the time of interview or thereafter, the candidate(s) shall not be allowed to appear in the interview or where the candidate has already appeared in interview, the candidature shall be deemed to have been cancelled ab-initio; and,

Whereas, upon verification of the documents of Dr. Nasir Ali, at the time of the interview, it was found that he is substantively working as Consultant Physician and is drawing salary against the available post of Assistant Professor, as per certificate dated 23.12.2021 issued by the Chief Accounts Officer, Jammu.

Whereas, experience should be teaching experience only, acquired by working against designated tenure or permanent posts. Since Dr. Nasir Ali was deputed to Govt. Medical College, Jammu in his capacity as Consultant Physician and he was not a Member of the teaching faculty in the Teaching Institution and has not worked in the capacity of a teacher, his experience was not considered for weightage. Further as per Rule 44 (iv) of J&K Public Service Commission (Business & Procedure) Rules, 2021, experience acquired "against a post" in a Government/Government recognized institute is to be considered for weightage, whereas, he is substantively working as Consultant Physician and is presently on deputation in GMC, Jammu.

Now, therefore, the representation of Dr. Nasir Ali, is considered in light of the orders of the Hon'ble Central Administrative Tribunal passed in O.A No. 61/211/2023 dated 01.03.2023 and found without any merit, and is, accordingly, rejected/disposed of.
