- 4. Whereas, all the objections/representations were referred to the Committee(s) of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
- 5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Keys in respect of the said papers;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that:-

a) The changes recommended by the Committee(s) of Experts are hereby adopted and the Final Official Key is annexed to this notification as Annexure A and B in respect of Medical Officer (Ayurvedic) and Medical Officer (Homoeopathy) respectively. In terms of Rule 10 (d) of the J&K
