Whereas, vide Notifications No.**PSC/Exam/2021/21 dated 08.03.2021** & No. **PSC/Exam/2023/03 dated 26.05.2023**, application forms from the desirous eligible candidates for appearing in **Excise and Commercial Part-II Departmental Examination**, were invited.
