Conduct of **Excise & Commercial Taxes Part-I** Departmental Examination regarding deficiencies thereof.

Whereas, vide Notifications No. PSC/Exam/2021/21 dated 08.03.2021 & No. PSC/Exam/2023/03 dated 26.05.2023, application forms from the desirous eligible candidates for appearing in Excise and Commercial Part-I Departmental Examination-were invited.
