Conduct of **Excise & Commercial Taxes Part-I** Departmental Examination regarding rejection notice-thereof.

Whereas, vide Notifications No. PSC/Exam/2021/21 dated 08.03.2021 & No. PSC/Exam/2023/03 dated 26.05.2023, application forms from the desirous eligible candidates for appearing in Excise and Commercial Part-I Departmental Examination-were invited. In response to these notices, 126 applications (under Notification No. PSC/Exam/2021/21 dated 08.03.2021) and 283 applications (under Notification No. PSC/Exam/2023/03 dated 26.05.2023) were received.

Whereas, on scrutiny of the application forms, it was found that out of <u>283</u> candidates under Notification No. PSC/Exam/2023/03 dated <u>26.05.2023</u>, forms in respect of <u>09 candidates</u> were found to be deficient. The deficiency/rejection Notice under Notification No. PSC/Exam/2021/21 dated <u>08.03.2021</u> has been already done vide Notice dated <u>19.07.2021</u>.

Whereas, vide Notice No. PSC/Exam/2023/04 dated 01.09.2023, these 09 candidates were advised to submit their deficient documents within stipulated time period. In response to the said notice, only 07 (Seven) candidates submitted their deficient documents and rest 02 (Two) candidates failed to submit their requisite documents.

Now, in view of the above, the candidature of **02 (Two)** candidates mentioned below is hereby rejected owing to the reasons as shown against each:-
