Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated: 24.03.2023, referred eight (08) posts (OM: 05, SC: 01, ST: 01, RBA: 01) of Assistant Professor (Clinical Biochemistry) to the J&K Public Service Commission, for selection; and,

Whereas, the J&K Public Service Commission, vide Notification No. 17-PSC (DR-P) of 2023 dated: 15.05.2023, advertised the said post; and,

Whereas, the written test was conducted on 27.08.2023 and the result thereof was declared vide Notification No. PSC/Exam/S/2023/51 dated: 12.09.2023; and,

Whereas, the viva-voce of the candidates was conducted on 18.09.2023; and,

Whereas, the Provisional Select List was issued vide Notification No. 55-PSC (DR-S) of 2023 dated: 20.09.2023; and,

Whereas, Mr. Feeroze Bhat was provisionally selected against the post of Assistant Professor, Clinical Biochemistry, under RBA category. He was also provisionally selected against the post of Assistant Professor, Biochemistry, under RBA category, and recommended to the Department for the post of PSC/DR/HE/AP No. letter vide Biochemistry Professor, Assistant Chemistry/2023 dated: 20.10.2023; and,

Whereas, Mr. Waseem Feeroze Bhat submitted an affidavit, dully attested by Additional Special Magistrate, Doda, wherein he has undertaken that he is withdrawing his candidature for the post of Assistant Professor, Clinical Biochemistry, as he has also been selected for the post of Assistant Professor, Biochemistry; and,

Whereas, the Commission in its meeting held on 30.10.2023 approved to recommend Mr. Masroof Ahmad S/o Mohd Sadullah Malik, being next in order of merit, having obtained 65.29 points against the post of Assistant Professor, Clinical Biochemistry, under RBA category, having become available in the wake of the withdrawal of candidature by Mr. Waseem Feeroze Bhat, and forwarding of his recommendation to the indenting Department.
