**Subject: Filling up of the posts of Combined Competitive Examination-2022-
Disposal of representation thereof.**

NOTICE

Whereas, Ms. Madhvi Raina appeared in the Combined Competitive Examination-2022 and figured in the provisional select list notified vide Notification No. PSC/Exam/2023/S/37 dated 22.8.2023 (deployment for Medical Examination); and

Whereas, as per the online application form of Ms. Madhvi Raina, she opted for Jammu & Kashmir Police (gazetted) Service as 1st preference and JKAS and JK Accounts Service as 2nd and 3rd preference, respectively; and

Whereas, on the basis of her merit and preference, she was allotted JK Police (Gazetted) Service which was the 1st preference given by her; and

Whereas, Ms. Madhvi Raina submitted a representation dated 10.10.2023 before the Commission for change of Service on account of medical reasons that she has had caesarean and prescribed bed rest for 4 months; and


Whereas, Ms. Madhvi Raina also filed a petition before the Hon'ble Central Administrative Tribunal, and the Hon'ble Tribunal vide order dated 26.10.2023, directed as under:-

"the Original application is disposed of with a direction to respondent No. 2 to decide the applicants pending representation dated 10.10.2023 by passing a reasoned and speaking order within a period of four weeks from the date of receipt of a certified copy of this order,. Before passing any order, the applicant shall also be afforded an opportunity of hearing. Respondent No. 2 is further directed to communicate the order so passed to the applicant."

Whereas, in compliance to the directions of the Hon'ble Central Administrative Tribunal, Ms. Madhvi Raina was called for hearing in the office of Hon'ble Chairman, J&K Public Service Commission on 3.4.2024.

Whereas, Ms. Madhvi Raina re-iterated the issues raised in here earlier representation and also submitted a fresh representation in this regard. During the hearing, it was observed that there are no reasons which warrant change of service allotment. Further, Rule 5 of SRO-103 dated 23.2.2018, also does not provide for any change of service once allotted to the candidate.

Now therefore, the claim of the petitioner has been found devoid of any merit and is hence rejected.
