Subject: Provisional Select List for the post of Horticulture Development Officer, in Agriculture Production Department (Horticulture).

## Notification No. 66-PSC (DR-S) of 2025 Dated: 28.04.2025

Whereas, Agriculture Production Department (Horticulture), vide letter No. Horti-Gaz/8/2021 (98948) dated 03.04.202 & 24.05.2023 referred Forty One (41) posts (OM: 20, RBA: 04, SC: 04, ST:04, ALC/IB: 02, SLC: 01, PSP: 02, EWS: 04) of Horticulture Development Officer, in Agriculture Production Department (Horticulture) to the J&K Public Service Commission, for selection of suitable candidates. The posts were advertised vide Notification No. 29-PSC (DR-P) of 2023 dated 09.06.2023 with cut-off date for determination of eligibility as 02.07.2023; *and*,

Whereas, the Commission in its meeting held on 09.04.2025 approved the selection of candidates for the post of Horticulture Development Officer under OM-20, RBA-04, SC- 04, ST-04, ALC/IB-02, SLC-01, PSP-01; *and*,

Whereas, One (01) post under PSP category & Four (04) posts under EWS category remained unfilled due to non-crossing of the bench mark/non availability of candidates with prescribed qualification (1st priority). As per the eligibility criteria fixed by the indenting Department, the Commission decided to conduct interview (2nd phase) in respect of the unfilled posts and Six (06) candidates as per their merit position were shortlisted for the interview- (03) Candidates under EWS category & (03) candidates under PSP category; *and*,

Whereas, the viva-voce of candidates was conducted on 28<sup>th</sup> April of, 2025 with the assistance of Experts. Out of the 06 shortlisted candidates called for interview, 02 candidates bearing Roll no.1700630 & 1700099 remained absent.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-**"**A**" to this Notification.



Consequent upon the details given here-in-above, Sajid Suhail S/O Mohammad Rafi R/O Tanghdhar Karnah who has secured 43.97 points is provisionally selected under (PSP Category) as Horticulture Development Officer, in Agriculture Production Department (Horticulture).

- 1. 04 posts under EWS category remained unfilled.
- 2. The Commission reserves the right to have certificates/documents of the candidate verified, if at any later stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
- 3. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
