Whereas, the Health & Medical Education Department vide Communication No ME-Gztd/246/2022 dated: 05.12.2022 and ME-Gztd/270/2022 dated: 01.11.2022, among others, referred 06 posts of Lady Medical Officer (RTHC), under OM category, one each, in Government Medical College, Anantnag, Doda, Kathua, Rajouri, Handwara and Udhampur, to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised vide Notification(s) No. 30-PSC (DR-P) of 2022 dated 30.12.2022, and No. 31-PSC (DR-P) of 2022 dated 30.12.2022, for the domiciles of Union Territory of Jammu & Kashmir, possessing the prescribed qualification; and,

Whereas, the written test was conducted on 04.11.2023 and 22 candidates were declared to have qualified the written test vide Notification No. PSC/Exam/S/2024/17 dated 25.04.2024; and,

Whereas, in view of the communication No. ME-GEN0Gaz/8/2024-01 (eoffice:7471934) from Health & Medical Education Department, the post of Lady Medical Officer, UTHC, in Government Medical College, Baramulla under OM category, notified vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022 was named as Lady Medical Officer, RTHC instead of Lady Medical Officer, UTHC vide Notice dated 14.10.2024; and
