## NOTICE Dated: 04-08-2025

Whereas, vide Notifications No. <u>PSC/Exam/21/2020 dated 15.10.2020</u>, No. <u>PSC/Exam/30/2022 dated 20.09.2022</u> and <u>No. PSC/Exam/2024/16</u>, <u>dated 27.11.2024</u>, application forms from the desirous eligible candidates for appearing in Junior Statistical Assistant and Statistical Assistant Course Departmental Examination were invited.
