Subject: O.A No. 592/2025 titled Shabir Hussain vs Controller of Examinations, JKPS & ors.- Disposal of representation thereof.

Order No: 42-(E) PSC of 2025

Dated: 05-08-2025

Whereas, the Commission vide Notifications No. PSC/Exam/2021/26 dated 22.03.2021 and No. PSC/Exam/2022/42 dated 27.12.2022 invited applications from the eligible candidates for appearing in the Accounts Clerk Course (ACC), SAC Part-I and SAC Part-II Departmental Examinations; and,

Whereas, the applicant namely Mr. Shabir Hussain S/o Sh. Khazir Mohmad, among others had applied under Item No. 8 (New) instead of Item No. 5 (Old) against notification No. PSC/Exam/2022/42 dated 27.12.2022 for Accounts Clerk Course (ACC) Departmental Examination in accordance with the provisions laid down in S.O. 297 dated 24.08.2021 and J&K Public Service Commission (Conduct of Examination) Rules, 2022; and,

Whereas, the applicant had passed Paper I, II and III (Old Course) in 2021 under Roll No. 86. Subsequently, the applicant has appeared for the Paper IV of ACC Departmental Examination (New Course) in 2024 and passed the said paper under Roll No. 147, the result of which was notified vide Notification No. PSC/Exam/S/2024/80 dated 18.12.2024; and,

Whereas, after declaration of the result, the applicant had represented before the Commission vide his representations dated 19.12.2024 and 23.05.2025 wherein it is requested to update the already passed Paper I, II and III of ACC departmental examination with Paper IV under New Course as his result under Notification No. PSC/Exam/S/2024/80 dated 18.12.2024 was shown as under:

Whereas, on receipt of these representations, the matter was examined and a written reply in this regard vide letter No. PSC/Exam/25/2023/SAC-I dated 19.06.2025 was given to Mr. Shabir Hussain whereby the request of updation of result was rejected; and,

Whereas, the applicant had filed OA in Hon'ble Central Administrative Tribunal at Srinagar and Hon'ble Tribunal in OA/592/2025 titled Shabir Hussain vs Controller of Examinations, JKPS & ors. has passed following order dated 05.06.2025:


"... this petition is disposed of with the direction to the respondents to treat this O.A as representation and consider and dispose of the same while taking note of all the pleas raised therein by the petitioner by passing a speaking and reasoned order. Respondents are further directed to do the needful expeditiously as possible but not later than two months to be reckoned from the date a copy of this order as also copy of the O.A along with all connected annexures is served upon them.

8. *In view of what has been discussed above, this O.A. No. 592/2025 is disposed of along with connected M.A, if any."*

Whereas, the representations dated 19.12.2024 and 23.05.2025 filed by Mr. Shabir Hussain were already disposed of as per the rule position mentioned in S.O 297 dated 24.08.2021 at Note 2 issued by the Finance Department which says that "A candidate who has applied or appeared in any of the Accounts Courses Examination prescribed under these rules but has not passed or whose result has not been declared before the date of issue of this notification, shall have an option either to be governed by the old syllabus or under the provision of the new syllabus of that particular Accounts Course Examination. Each such candidate will exercise his option in writing to the Secretary, Public Service Commission within one month of the issue of this Notification or after the declaration of the result." However, the present scenario is appearing partially in Old Course and partially in New Course examination which is not covered under the Note 2 of S.O. 297 dated 24.08.2024; and,

Now, therefore, in view of aforesaid facts and in due deference to the Order dated: 05.06.2025 passed by Hon'ble Central Administrative Tribunal, Srinagar Bench in OA 592/2025 titled Shabir Hussain vs Controller of Examinations, JKPSK and ors., the representation submitted by the applicant had been considered and found devoid of any merit and hence rejected
