**Subject:** Filling up of the post of Assistant Professor, Mechanical Engineering (GCET) in Higher Education Department-Rejection of candidature thereof.

Whereas, the Higher Education Department vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, among others, referred (09) post (OM=05, RBA=01, SC=01, ST=01, EWS=01) of the post of Assistant Professor, Mechanical Engineering (GCET) in Higher Education Department, to the J&K Public Service Commission for selection; and,

Whereas, the said post was advertised, vide Notification No. 11-PSC (DR-P) of 2023 dated 05.04.2023, and

Whereas, the written test was conducted on 22.10.2023, and the result thereof was declared vide Notification No. PSC/Exam/S/2025/03 dated 25.01.2025; and,

Whereas, upon scrutiny of the documents, it has been found that some candidates have not submitted the requisite documents, and accordingly vide Notice dated 01.08.2025, they were advised to submit the deficient documents in the office of J&K, Public Service Commission, Solina, Srinagar/Resham Ghar Colony Jammu, within 10 (Ten) days from the date of issuance of the said Notice, failing which their candidature shall be deemed to have been rejected without any further notice.

Whereas, in response to the ibid Notice dated 01.08.2025 all candidates submitted the documents which were asked to them vide ibid notice, excepting, Mr. Asaf Hanief Kohli within the prescribed time of 10 days; and,

Whereas, Mr. Asaf Hanief Kohli, submitted the application dated 04.09.2025, received by this Commission on 08.09.2025, wherein he requested to accept deficient documents as called from him vide Notice dated 01.08.2025 as he had ill health and he could not submit the deficient documents; and,

Whereas, the case was examined in the Commission, and it was found that Mr. Asaf Hanief Kohli submitted the deficient documents after the cut of date specified in Notice dated 01.08.2025; and
