Filling up of the post of Physical Training Instructor, in GCET/GDC in Higher Education Department- Rejection of candidature thereof.

Notice Dated:16.10.2025

Whereas, the Higher Education Department, vide letter No. HE-Coll/Coord/Appt/AP/2014 dated 25.09.2020 and HED-GAZ/85/2022-04 dated 13.04.2022, among others, referred 53 posts of Physical Training Instructor (OM=27, RBA=05 SC=05, ST=05, ALC/IB=02, SLC=02, PSP=02, EWS=05), in Higher Education Department, to the J&K Public Service Commission for selection; and,

- 02- Whereas, the posts were advertised, vide Notification No. 08-PSC (DR-P) of 2023 dated 01.03.2023; and,
- Whereas, the Higher Education Department, again vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, among others, referred 03 posts of Physical Training Instructor (OM=01, RBA=01 SC=01), in GCET in Higher Education Department, to the J&K Public Service Commission for selection; and
- 04. Whereas, the posts were advertised, vide Notification No.11-PSC (DR-P) of 2023 dated 05.04.2023; and
- Whereas, the written test was conducted on 17.03.2024, jointly for both the Notifications. The result thereof was declared vide Notification No. PSC/Exam/S/2025/25 dated 25.04.2025; and,
- 06. Whereas, upon scrutiny of the documents, it has been found that among others, the following two candidates have not submitted the documents, as indicated against each:-

Whereas, the Commission vide Notice dated 25.06.2025, among others, both the above mentioned-candidates were also advised to submit their deficient documents at J&K Public Service Commission, Solina, Srinagar/Resham Ghar Colony Jammu, within 10 (Ten) days from the date of issuance of this Notice, failing which their candidature shall be rejected without any further notice; and,

08- Whereas, in response to the Notice dated 25.06.2025, Mr. Mushtaq Ahmad Sofi and Mr. Shoib Ahmad Khan submitted documents which were again scrutinized and it has been found that both the candidates have not submitted Result notification of Ph.D.

Now, therefore, the candidature of Mr. Mushtaq Ahmad Sofi, Roll No. 4300060 and Mr. Shoib Ahmad Khan, Roll No. 4300104 is hereby rejected. If the candidates feels aggrieved with their rejection, they may represent before the Appellate Authority of the Commission, with evidence in support of their claim within 10 days from the date of issuance of this Notice. No claim whatsoever shall be entertained after the stipulated period.
