Subject: Provisional Select List for the post of Deputy Medical Superintendent, in Government Medical College Srinagar in Health & Medical Education Department.

Notification No. 74 -PSC (DR-S) of 2025

Dated: 03.11.2025

Whereas, the Health & Medical Education Department, vide letter Nos. MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022 (e-office), dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022, referred four (04) posts of Deputy Medical Superintendent, **(OM-02, RBA-01, SC-01) in GMC Srinagar**, to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, the posts were advertised vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023. The cut-off date for determination of eligibility was fixed as 30.06.2023; **and**,

Whereas, a written test was conducted on 17.03.2024. The result of the written test was declared vide Notification No.PSC/Exam/S/2024/12 dated: 03.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and**,

Whereas, **04** candidates were called for interview against Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023; **and**,

Whereas, the viva-voce of candidates was conducted on 09.09.2024, with the assistance of Experts from outside of UT; **and**,

Whereas, Dr Kulbir Singh Jat, whose candidature for the post was rejected for having no relevant experience, filed an application before the Hon'ble Central Administrative Tribunal, Srinagar for treating him eligible for the post. The Hon'ble Central Administrative Tribunal, in the application bearing No. OA /581/2024 and O.A 573/2024 titled Dr. Kulbir Singh Jat V/S Health & Medical Education Department, on 12.08.2025 ordered that:

"It is also ordered that the PSC shall conduct interview within four weeks which according to the learned counsel for the petitioner is a reasonable period and till the interview of the petitioner is conducted, the PSC shall not declare any of the results for the post to be filled up and as regards the result of the petitioner, the same shall be produced before the court in a sealed cover. As regards the rest of the notifications in which the petitioner has not qualified, the respondents are free to declare the results of the same.

Whereas, in compliance to the directions of the Hon'ble Central Administrative Tribunal, Dr. Kulbir Singh Jat was interviewed on 16.09.2025 by the Interview Board; and,

Whereas, the Hon'ble Central Administrative Tribunal on 28.10.2025 passed an order, the operative part of which is reproduced below:-

On 12-08-2025, a detailed order was passed by the court in this matter, whereunder the respondents were directed not to declare the result till the interviews, as regards the petitioner herein, were conducted and concluded. They were further directed to produce the result in a sealed cover before the court as regards the notification No. 28-PSC (DR-P) of 2023 dated 08-06-2023.....

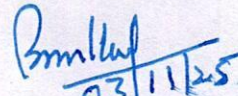
...the order dated 12-08-2025 is modified to the extent that the respondent - PSC, will proceed further in the matter by issuing the orders strictly in accordance with the merits of the case as also in terms of rules governing the field. Needful to be done as expeditiously as possible but not latter than three weeks. Respondents are further directed to go ahead with the selection process.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-A** to this Notification.

Consequent upon the details given here-in-above, the candidates whose particulars are given in **Annexure-B** to this Notification, are provisionally selected against the said posts.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. Two posts, one each in RBA and SC categories remained vacant due to non-availability of candidates.

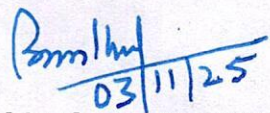
