02- Whereas, the post was advertised vide Notification No. 10-PSC (DR-P) of 2022 dated 26.04.2022; and,

03- Whereas, the prescribed qualification for the post as per Recruitment Rules is as under:-


- i. *First Class Masters Degree in any branch of Science / Mathematics/ Statistics or First Class Masters Degree in Engineering from any recognized Institution/University.*
- ii. *Two years of experience in the field of Research in Design and Innovation from any recognized Institution.*
- iii. *Explanation: "Only such experience shall be considered which has been acquired by the candidate after post graduation as Design Fellow from the recognized Institution".*

04- Whereas, the written test was conducted on 10.06.2025, and the result thereof was declared vide Notification No. PSC/Exam/S/2025/47 dated 12.11.2025; and,
