Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred One (01) post (OM Category), of Lecturer, Statistics, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said post for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; **and,**

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 29.09.2025; **and,**

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/51 Dated: 12.11.2025. Five (05) candidates were declared to have qualified for interview provisionally; **and,**


Whereas, the viva-voce of candidates was conducted on 29.12.2025, with the assistance of Experts from outside of the Union Territory of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43,1(i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

Consequent upon the facts stated here-in-above, **Sameer Ahmad Wani S/O Abdul Hamid Wani R/O 383 Daribal Ganderbal** having secured **82.56** points, is provisionally selected against the said post.

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The selection of the candidate is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
