Whereas, the Health & Medical Education Department, vide letter No, ME-Gztd-525/2023-01 (CC: 7331789), dated 09.07.2024, referred two (02) posts (OM:01, SC:01) of Assistant Professor, Anaesthesiology, to the J&K Public Service Commission, for selection of suitable candidates.; and,

Whereas, the said posts were advertised vide Notification No. 03-PSC (DR-P) of 2025 dated 04.02.2025. The cut-off date for determination of eligibility was fixed as 05.03.2025; and,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 44,ii(a) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 07.10.2025; and,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/53 Dated: 12.11.2025. Five (05) candidates were declared to have qualified for interview provisionally; and,

Whereas, the viva-voce of candidates was conducted on 15.01.2026, with the assistance of Experts from outside of UT.


Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii)(a) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

Consequent upon the facts stated here-in-above, **Aymen Masood D/O Masood Ahmad Khan R/O 60 Chinar Colony, Baghat** having secured **80.60** points, is provisionally selected against the post of open merit .

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.

2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. One post of SC category remained vacant due to non-availability of candidate.
