Whereas, the Health & Medical Education Department, vide letter No, ME-Gztd-525/2023-01 (CC: 7331789), dated 09.07.2024, referred one (01) post (OM Category) of Assistant Professor, Obsts & Gynae, to the J&K Public Service Commission, for selection of suitable candidate.; and,

Whereas, the said post was advertised vide Notification No. 03-PSC (DR-P) of 2025 dated 04.02.2025. The cut-off date for determination of eligibility was fixed as 05.03.2025; and,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 44,ii(a) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 07.10.2025; and,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/53 Dated: 12.11.2025. Five (05) candidates were declared to have qualified for interview provisionally; and,

Whereas, the viva-voce of candidates was conducted on 16.01.2026, with the assistance of Experts from outside of UT.


Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii)(a) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

Consequent upon the facts stated here-in-above, **Aaliya Tabasum** D/O **Bashir Ahmad Qazi** R/O **02 Doctors lane Channi Rama Jammu** having secured **72.40** points, is provisionally selected against the said post .
