Whereas, written test was conducted on 10.06.2025. The result of the written test was declared vide Notification No. PSC/Exam/S/2025/30 Dated: 12.08.2025, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; **and,**

Whereas, the viva-voce of candidates was conducted on 29.01.2026 with the assistance of Experts from outside of the UT of J&K. Two candidates remained absent, as such, interview of 08 candidates only was conducted.


