Whereas, the posts were advertised vide Notification No.03-PSC(DR-P) of 2025 dated 04.02.2025; and

Whereas, the written test was conducted on 07/08.10.2025 and 10 candidates were declared to have qualified the written test provisionally, vide Notification NO. PSC/Exam/S/2025/53 dated 12.11.2025; and

Whereas, vide Notice dated 19.12.2025, among others, the following candidates were advised to furnish the deficient documents as indicated against each:

Whereas, upon verification of documents submitted by the above candidates in response to the Notice dated 19.12.2025, the candidature of the candidates is hereby rejected for the reasons indicated against each:

S. No.	Name	Reasons for rejection
01.	Rayees ul Hamid Wani	The candidate has not responded to the Notice.
02.	Aijaz Ahmed Bhat	The publication viz. Clinical and Epidemiological profile of H1N1 influenza A in Kashmiri Children is not indexed in database mentioned in the rule, quoted in advertisement Notification.
03.	Zubair Ahmad Najar	The candidate has submitted only one(01) publication viz; "Life Style patterns and adherence to pharmacotherapy after..." as against requirement of 02 publications, as per rule quoted in the advertisement notice.

Now, therefore, the candidature of the above mentioned candidates is hereby rejected with stipulation to represent before the Appellate Authority, if they so desire, with documentary evidence in support of their claim, if any. No claim shall be accepted after cut-off date and no further notice shall be given.
