**Subject:** Result of J&K Civil Services (Judicial) Examination, 2025

## PRESS RELEASE FEBRUARY 24, 2026

The Law, Justice & Parliamentary Affairs Department, had on 07.04.2025, referred 42 posts of Civil Judge (Junior Division) to the J&K Public Service Commission for being filled up through the Competitive Examination.

Accordingly, these posts were advertised by the Commission on 14.05.2025. The Preliminary Examination was conducted on 28.09.2025 in which 2974 candidates appeared in full. The result of the preliminary examination was declared on 13.10.2025. 1016 candidates were declared to have qualified for appearing in the J&K Civil Services (Judicial) [Mains] Examination-2025.


966 candidates actually appeared in the said Examination which was held from 16.11.2025 to 26.11.2025, out of which 124 candidates were declared to have qualified for appearing in the interview/personality test. The interviews were held from 17.02.2026 to 24.02.2026.

The Commission in its Extra Ordinary Meeting held today on 24.02.2026, after the conclusion of the interviews, decided to declare the result of all the candidates who had appeared in the interview and also notify their aggregate marks while publishing a list of candidates to be summoned for Medical Examination in accordance with the relevant rules.

**Commission congratulates Mr. Anshul Lal Sharma S/o Sh. Kuldeep Raj Sharma 24 years old, Law Graduate, who has topped the overall list securing 615.75 Marks.**

For convenience of the candidates, they are requested to attend any of the two Government Medical Colleges (GMC- Srinagar/Jammu) for medical examination.

It is pertinent to mention that the J&K Public Service Commission completed the process of selection, based on a three-tier examination comprising the Preliminary, the Mains and the Personality Test/ viva-voce in only nine months.
