

Note:


- i. For checking the result, candidates are advised to access the official website of the Commission i.e. <http://www.jkpsc.nic.in>.
- ii. The candidature of candidates shown in **Annexure-A, B and C** are purely provisional. The documents of the candidates will be verified at the time of interview and in case any discrepancy with regard to age/qualification/experience and other eligibility conditions is noticed at the time of interview or thereafter, the candidate shall not be allowed to appear in the interview or where the candidate has already appeared in the interview, the candidature shall be deemed to have been cancelled *ab-initio*.
- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.

iv. The candidates shall produce their original certificates/ testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.




