Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred forty nine (49) posts (OM: 20, RBA:05, SC:04, ST-1:05, ST-2: 05, ALC/IB: 02, OBC (SLC):04, EWS: 04) of Lecturer, Political Science, to the J&K Public Service Commission, for selection; and,

Whereas, these posts were advertised vide Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024; and,

Whereas, the written test was conducted on 09.11.2025 and the result thereof was declared vide Notification No. PSC/Exam/S/2026/14 dated: 23.01.2026. The viva-voce of the candidates was conducted from 07.04.2026 to 15.04.2026; and,

Whereas, the Provisional Select List for the post of Lecturer, Political Science, in School Education Department was notified vide Notification No. 27-PSC(DR-5) of 2026 dated 15.04.2026 with a stipulation that the selection is provisional and objections, if any, may be submitted to the commission within five days; and


Whereas, in response to the ibid notification, one candidate, namely, Mr. Akeel Ahmad Dar has submitted representation/objection against the Provisional Select List:-

Whereas, the objection raised in the representation and consideration is given here-under:

	secured 50.12 points out of 78 in the written examination, whereas he has secured more than 52 points under the same category but was not shortlisted for the interview. Requested for re-evaluation of his OMR sheet to rule out any inadvertent error.	examination were below the cut off marks under the OM category. The claim of the applicant that he secured higher marks than the last selected candidate is factually incorrect and devoid of merit.
