Subject: Filling up of the post of Lecturer Botany in School Education Department- disposal of representation thereof.

Whereas, the School Education Department vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and dated 05.12.2024 referred 52 posts of Lecturer, Botany in School Education Department to the Jammu and Kashmir Public Service Commission for selection; and

Whereas, the said posts were advertised vide Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024; and

Whereas, the written examination for the said posts was conducted on 12.10.2025 and the result thereof was declared vide Notification No. PSC/Exam/S/2025/61 dated 01.12.2025; and

Whereas, interview of the qualified candidates was held from 16.04.2026 to 24.04.2026 and Provisional Select List for the post of Lecturer, Botany in School Education Department was notified vide Notification No. 33-PSC (DR-S) of 2026 dated 24.04.2026 with a stipulation allowing claims; and

Whereas, in response to the ibid Notification, one Mr. Komal Verma, submitted a representation stating that she had applied for the post of Lecturer in Botany vide Application No. 24010720401044 and appeared in written test as well as interview. However, 06 points on account of Ph.D degree has not been awarded in aggregate points and; and,


Whereas, upon examination of the records, it was found that an inadvertent typographical error had occurred in the Ph.d Column and 06 points on that account have not been relected and thereby total points also showing these points less; and,

Whereas, the case of the candidate was placed before the Commission for consideration and decision in the matter.

The Commission in its meeting dated 04.06.2026 decided as under:

"The Commission decided to rectify the inadvertent typographical mistake in the result shown against Mr. Komal Verma and add 06 points for being Ph.D., to his score. Consequently, her points shall be read as 66.29 instead of 60.29."

Now, therefore, the score of Mr. Komal Verma shall be read as 66.29 instead of 60.29 in the Annexure to Notification No. 33-PSC (DR-S) of 2026 dated 24.04.2026 for the post of Lecturer, Botany in School Education Department, against S. No. 46, under SLC category.
